BOARD OF APPEALS

Notice is hereby given that the Board of Appeals of the Town of Weston has made a decision granting to Weston Community Housing, Inc., c/o Victor C. Harnish, Esq., 675 Main Street, Waltham, Massachusetts, modifications to the site-plan approval in the special permit granted August 22, 1977, for construction of multiple dwellings located on premises at Village Road, Weston.

The Board made a decision that the site plan is to be modified as shown on Keyes Associates Site Plan, Job No. C-7752, Rev. 6, dated 10/23/78, on file with the Board.

The modifications are:

1. A space directly in front of the main entrance and walkway of the apartment building on the north side of the parking lot will be kept open for emergency access and egress.
2. This emergency space will be indicated by painting with diagonal lines.
3. The parking space lost in the modified layout will be replaced by another space to maintain the ratio of one and one-half spaces per apartment.
4. Walkways from main entrances of all buildings will be extended to connect to their adjacent parking areas for emergency access.

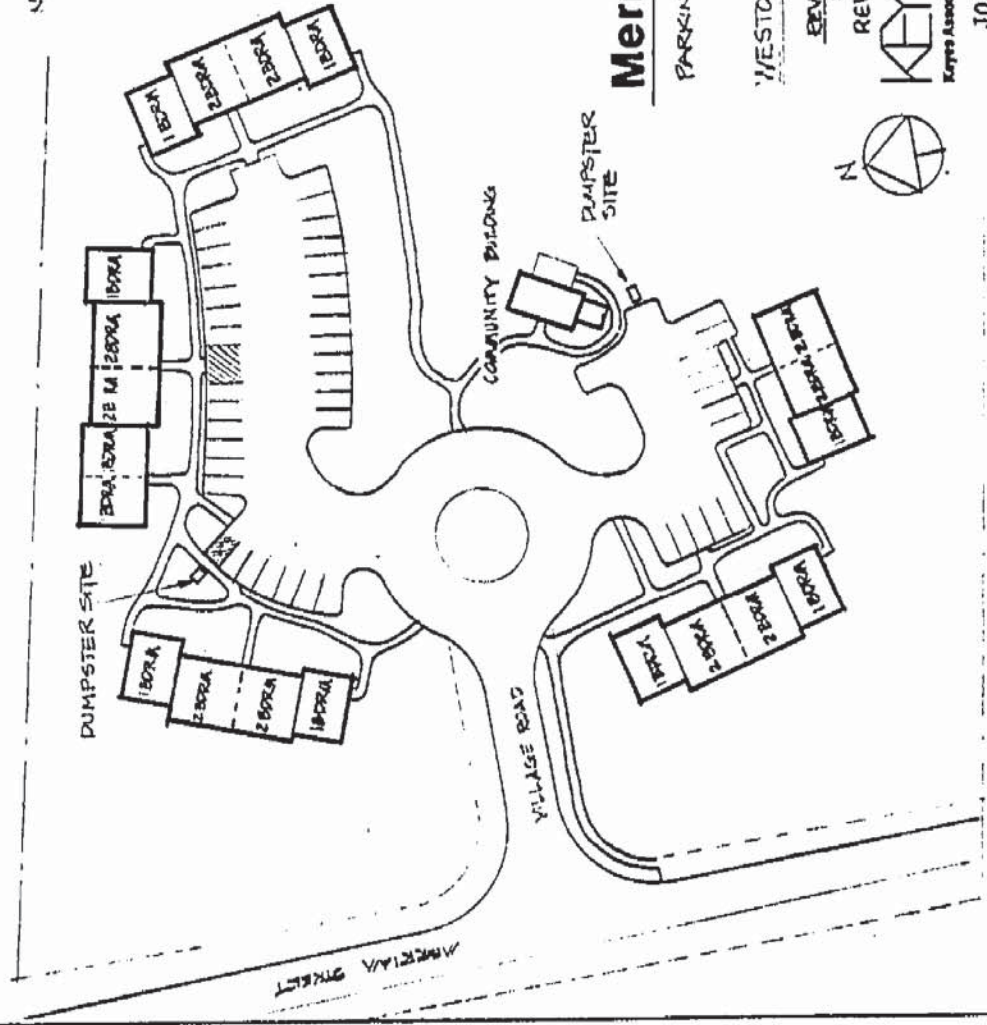
